## March 5, 2024, Presidential Primary Election Update – Canvass

(Woodland, CA) - The Yolo County Elections Office began the canvass for the March 5, 2024, Presidential Primary Election on Thursday, March 7, 2024. The canvass takes place at the Yolo County Elections Office located at 625 Court Street, Suite B-05 in Woodland. Members of the public are invited to observe.

Please be advised that unsigned identification envelope and signature verification statements have been mailed to Yolo County voters whose signature on the vote-by-mail envelope was challenged by the Yolo County Elections Office. Challenges occur when the envelope is missing a signature or the signature does not match the signature within the voter file. These forms must be returned to the Elections Office by Wednesday, March 20, 2024, by 5:00 p.m.
