## Combined Signature Verification and Unsigned Identification Envelope Statement & Instructions

READ THESE INSTRUCTIONS CAREFULLY BEFORE COMPLETING THE STATEMENT.

FAILURE TO FOLLOW THESE INSTRUCTIONS MAY RESULT IN YOUR VOTE-BY-MAIL BALLOT NOT BEING COUNTED.

1. We have determined either that the signature you provided on your vote-by-mail or conditional/provisional ballot identification envelope does not match the signature(s) on file in your voter record **OR** that you did not sign your ballot identification envelope. To ensure your ballot is counted, this completed Statement must be returned as soon as possible and **received no later than 5:00 p.m. two days prior to the certification of the election.** Please contact the Elections Office at (530) 666-8133 or [elections@yolocounty.gov](mailto:elections@yolocounty.gov) for the exact date.

3. You must sign the form (your signature or a witnessed "mark") and include your complete residence address.
4. Your completed Statement may be returned by:
  - Mail or hand deliver to: **Yolo County Elections, 625 Court Street, Suite B-05, Woodland, CA 95695.** You may use the postage paid return envelope provided by the Yolo County Elections Office **OR**, if using your own envelope, be sure there is sufficient postage and that the address of our office is correct. **Postmarks will not count.**

  - Hand deliver to an open voting location within the county or a county Ballot Drop Box **before** polls close at 8:00 p.m. on Election Day.
5. Please note the signature on this completed Statement may be added to your registration record to be used for signature comparison purposes in future elections.

I declare under penalty of perjury that I requested (or I received) and returned a vote-by-mail or conditional/provisional ballot and that I have not and will not vote more than one ballot in this election. I am a resident of the precinct in which I have voted, and I am the person whose name appears on the vote-by-mail or conditional/provisional ballot envelope.

I understand that if I commit or attempt any fraud in connection with voting, or if I aid or abet fraud or attempt to aid or abet fraud in connection with voting, I may be convicted of a felony punishable by imprisonment for 16 months or for two or three years.

I understand that my failure to sign this Statement means that my vote-by-mail or conditional/provisional ballot will be invalidated.
